

About the terms

Access to and use of 'huda.tv' both within the local and internationally is provided by the HudaTV (international users of the site may see some advertising on certain pages which is provided by the HudaTV on the following terms:

1. By using 'huda.tv' you agree to be bound by these terms, which shall take effect immediately on your first use of 'huda.tv'. If you do not agree to be bound by all of the following terms please do not access, use and/or contribute to 'huda.tv'.

2. The 'huda.tv' may change these terms from time to time and so you should check these terms regularly. Your continued use of 'huda.tv' will be deemed acceptance of the updated or amended terms. If you do not agree to the changes, you should cease using this website. If there is any conflict between these terms and specific local terms appearing elsewhere on 'huda.tv' (including house rules) then the latter shall prevail.

Use of 'huda.tv'

3. You agree to use 'huda.tv' only for lawful purposes, and in a way that does not infringe the rights of, restrict or inhibit anyone else's use and enjoyment of 'huda.tv'. 'huda.tv' communities

13. In order to participate in and contribute to selected 'huda.tv' communities you may be required to register with 'huda.tv'. Any personal information supplied to 'huda.tv' as part of this registration process and/or any other interaction with 'huda.tv' will be collected, stored and used in accordance with the 'huda.tv' Privacy Policy.

14. You agree to use 'huda.tv' communities (including message boards) in accordance with the following Community Rules. These apply across all 'huda.tv' community sites and services. (i) About your posts:

- **Contributions must be civil and tasteful.**
- **No disruptive, offensive or abusive behaviour:** contributions must be constructive and polite, not mean-spirited or contributed with the intention of causing trouble.

- **No impersonation.**
- **No inappropriate (e.g. vulgar, offensive etc) user names.**
- **URLs** (web site addresses) can only be posted if allowed under any relevant local house rules.
- **Deliberate misuse of the complaints facility is not permitted.** If you persist in doing this, action may be taken against your account.

(ii) Your 'huda.tv' Account:

If you use multiple logins for the purpose of disrupting a community or annoying other users you may have action taken against all of your accounts.

All accounts must be registered with a valid personal email address that you access regularly so that moderation emails can be sent to you. Accounts registered with someone else's email address, or with temporary email addresses may be closed without notice. We may require users to re-validate their account if we believe they have been using an invalid email address.

The 'huda.tv' reserves the right to close accounts if any user is seen to be using proxy IPs (Internet Protocol addresses) in order to attempt to hide the use of multiple 'huda.tv' accounts, or if a non UK user pretends to be a UK user, or disrupts any of our services in any way.

(iii) Safety:

We advise that you never reveal any personal information about yourself or anyone else (for example: telephone number, postal address, home address or email address or any other details that would allow you to be personally identified) in any 'huda.tv' community.

21. These terms shall be governed by and interpreted in accordance with the laws of England and Wales which shall have exclusive jurisdiction over any disputes.
